

FOR ALL DRIVERS AND SPECTATORS: YOU MUST READ THIS CAREFULLY

Release of Liability, Waiver, and Acknowledgements

In exchange for participation in the activity and/or spectatorship of racing, organized by Northern Racing Unlimited Inc., (hereinafter referred to as “NRU”), I agree for myself, for the members of my family whether they are under the age of majority, and for my guest(s) to the following.

- 1) I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by NRU, or the employees, representatives or agents of NRU.
- 2) I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury to myself, my family members, my guest(s), and further release and discharge NRU for death, dismemberment, injury, loss or damage arising out of my, my guest(s), or my family’s use of or presence upon the facilities of NRU, whether caused by the fault of myself, my family, my guest(s), NRU, or other third parties.
- 3) I acknowledge and agree that I, nor my guest(s), or my family, will not be intoxicated by way of alcohol, drugs, or any other form of intoxication of a mood or mind altering substance while attending the event as either a participant in the race or as a spectator.
- 4) I recognize that absolutely no firearms or weapons of any kind are allowed at the event or appurtenant thereto.
- 5) I recognize and acknowledge that the advertising sponsors of this event played no role in the organization, planning or implementation of the event itself. I hereby waive and/or release any and all claims against the sponsors stemming from any wrongdoing on NRU’s behalf or otherwise associated with the event itself.
- 6) All photographs, still and moving, captured on the premises are property of NRU.
- 7) I agree to indemnify and defend NRU against all claims, causes of action, damages, judgments, costs or expenses, including lawyer fees and other litigation costs, which may in any way arise from me, my guest(s), or my family’s use of or presence upon the facilities of NRU.
- 8) I agree to pay for all damages to the facilities of NRU caused by myself, my family, or my guest(s) negligent, reckless or willful actions.
- 9) I agree that if requested by NRU, I will sign any further release of liability, waiver, or acknowledgement if I do so agree thereto upon request by NRU or I will not be allowed to participant in the racing event and or spectate. If any, release of liability, waiver, or acknowledgement, is left unsigned, you will not be refunded your ticket cost.
- 10) I understand that this event is called “No Prep Mayhem”. “No Prep” means that the track was not prepared, or prepared with very little, compounds, to make tires stick to the pavement. This style of racing is a lot like street racing insofar as no preparation is done on street racing prior to street racing events. You acknowledge that a no prep event is therefore innately is even less safe than an event where a track/dragstrip has been prepared for use.
- 11) I understand that all aspects of this liability release apply to my vehicle, regardless of if I am the one driving it.

12) Any legal or equitable claim that may arise from participation in the above shall be resolved under the laws of the province of Ontario.

I HAVE READ THIS DOCUMENT AND UNDERSTAND IT. I FURTHER UNDERSTAND THAT BY SIGNING THIS RELEASE OF LIABILITY, WAIVER, AND ACKNOWLEDGEMENT I VOLUNTARILY SURRENDER CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE, AND DO HEREBY ACKNOWLEDGE DUTIES AS EITHER A PARTICIPANT AND/OR SPECTATOR OF THE RACING EVENT. I SIGN THIS DOCUMENT VOLUNTARILY AND WITHOUT INDUCEMENT.
